9th Annual Gary Gore Memorial Golf Tournament Slated May 30th

The Ninth Annual Gary Gore Golf Tournament will be held Friday, May 30th at The Club at StoneRidge. Members are encouraged to sponsor and participate in a fun-filled event. The tournament is a way to link business with pleasure, and provides an opportunity for participants to network with other business professionals in a casual and relaxed environment. Registration begins at 11 a.m., with a Shotgun Start at 1 p.m.

The tournament memorializes Gary Gore, who died in a watercraft accident at Wilson Lake in 2005. Local golf professional Steve Gotsche will administer the tournament as one of his last in Great Bend before relocating to Manhattan, Kansas. Proceeds from the tournament support the operations of the Great Bend Chamber of Commerce & Economic Development.

Players can look forward to a four-man scramble format with over \$4,000 in prizes and raffle drawings. Hole contest prizes will be sponsored by Bauer & Pike, LLC and Bentley & Associates Inc. A beverage cart will be available, sponsored by Benefit Management Inc.

"We are excited about a new addition to the fun-filled event," says Andrea Bauer, Director of Sales & Member Services. Barton Community College officially unveiled its newly remodeled Fine Arts Auditorium during an open house event in late March. Following remarks from the college president Dr. Carl Heilman, chair of the Board of Trustees Mike Johnson, chair of the Foundation Board Judy Fox, and Foundation Executive Director Darnell Holopirek, members of the community were invited to enjoy a special presentation featuring live performances from Barton students.

More than a year of planning went into the renovation of the Fine Arts Auditorium. New features include a reconfiguration of seating to create aisle accessibility and a better viewing experience. One of the most notable upgrades was with the equipment behind the scenes. State-of-the-art sound and lighting will enhance the audience experience, making it easier to see and hear the events on the stage.

Gary Parr with Parr Sound & Lighting, the company who installed much of the new high-tech equipment, explained to audience members the benefits of utilizing the latest technology. "These students are being trained with the same equipment being used in the performing arts industry today, not the stuff of decades ago," Parr said. "This means they are better equipped for the real world. This set-up also uses less than half the power to operate even more equipment, so it's a win-win."

The foyer area of the Fine Arts Building received new paint, soffit, display cases, lighting, artwork and an ornate, wall-sized donor plaque that pays tribute to all who have donated funds to various fine arts enhancements. Golden Belt Home Health & Hospice Celebrates 35th Year Providing Services

It was 35 years ago this spring that Golden Belt Home Health & Hospice (GBHH&H) offered services to its first patient. When 1979 came to an end, the non-profit agency had cared for 43 patients. Today, at any given time, GBHH&H is serving 60-100 patients for an average of almost 300 per year.

Donita Wolf, GBHH&H director, recently outlined the agency's background and services during a Great Bend Chamber of Commerce Coffee. Under the leadership of Sister Dominic, the local Dominican Sisters determined there was a need for home-health care, Wolf said.

"The Sisters were out in the community doing their volunteer work with the elderly and soon realized professional nursing services were needed in family homes," Wolf explained. "Our agency became Medicare certified and began providing nursing and nursing-aide services."

In 1982 the agency expanded to include hospice services - also in family homes. Medicare changes in 2000 brought about the closure of four other home-health agencies but GBHH&H remained open. "We were going strong then and continue to do so to this day," Wolf said. "We have a great staff of medical and clerical personnel. There are 21 of us who are dedicated to patients and their families."

Home health includes a wide variety of services such as wound care; IV therapy; physical, speech and occupational therapies; and rehabilitation after an accident or stroke. "Home-health services are available to anyone who has had a change in medical status for whatever reason," Wolf said. "We will take care of them for as long as there is a need."

Hospice services, which also are provided in the home, are needed when the patient is terminal. "Our hospice team provides comfort when the patient is no longer receiving traditional medical treatment," Wolf said. "We can help manage their symptoms and be helpful to the family at this difficult time. Our grief support group also is helping many families in the area."

In addition to the patient's physician, the hospice team includes the medical director, nurses, a social worker, chaplain, aides and volunteers. "I am very proud of this compassionate group of caregivers," Wolf said.

GBHH&H, 3520 Lakin, is part of the St. Rose Ambulatory & Surgery Center family. St. Rose is under the umbrella of Centura Health. GBHH&H serves families in Barton, Pawnee, Rush and parts of Stafford counties. For more information, call 620-792-8171.

Some of the oilfield guys who became acquainted with David Thill referred to him as that "crazy banker." But they may have changed their tune in recent years - now that Thill's company handles about 40 percent of the vertical oilfield casing business in Kansas.

Thill is co-owner of D & S Casing Crews LLC with his wife, Shellie; their initials created the company name. "I was president of Sunflower Bank in Great Bend and Ellinwood," Thill said. "I was there for eight years and decided I wanted to do something different."

"I knew the oilfield casing business because I put myself through college working for Francis Casing Crews, which was a long-time family business here," he noted. "This was a major change. I was in a suit-and-tie profession and went to the oilfield. I left job security and benefits, along with an inside desk environment, which is why I became known as the 'crazy banker.'"

D & S Casing Crews, 4713 8th, opened in March 2008. Thill and two investors started in 25-by-50-foot mechanic-shop spaces just to the east of this current location. "We started with one space, big enough for one truck, then two, then three," Thill recalled. "In January of 2013, we moved into this 7300 square foot building, which we designed specifically for a casing business."

"For one type of job you need specific equipment and for another job, different equipment," he explained. "So we put in a bridge crane to go from one set of tools to the next. Before this, trucks had to be moved in and out of the building. This crane makes us more efficient and safer."

When D & S opened early in 2008, there were 95 drilling rigs operating in western Kansas; by the end of that year, there were only 27 still operating. "That's when we questioned what we had done," Thill laughed. "But we used that time as an opportunity. Then the price of oil started going back up."

Before Thill started the business, he analyzed the competition and decided he would have to take service to the next level. "I knew we would have to be better than our competition," he explained. "So we decided to focus on three priorities - being clean cut, well-trained and drug tested."

D & S Casing started with four employees and now has 28, including a safety manager. "This is an unbelievable group of people, that I'm proud of" Thill said. "This is one of the most physically demanding jobs in the oilfield and we are on 24-hour call. Maybe other jobs are as physically demanding but they don't go day and night. Our guys need agility and strength; they are like the athletes of the oilfield."

"I have a high level of respect for our employees," he added. "They stick with us and we take care of them. Our focus is to improve on a superior level of service. It is our competitive edge."

Since the entire state of Kansas is D & S's territory, the crews work with different people and companies on a regular basis. "Our guys adapt to this," Thill commented. "We even help the drilling companies with the changeover to get ready to run the casing. They appreciate this so much; it cuts time and, therefore, cuts costs. Another plus, it creates a great working relationship with our customers."

"This is our philosophy on how to grow the business - bring service to a higher level," he added. In the early days, Thill went to rig locations with his employees and performed all the casing tasks. "That's how we grew our market; I can't do that as often now."

D & S receives calls from rotary rigs that need a casing crew on site in 8-12 hours. "You either commit or you don't," Thill said. "You have to have a crew on stand-by, ready to go. We are dedicated to hiring responsible people but if someone is unavailable, I will get out of bed and go."

The business started with one crew and recently added a sixth. These crews help install the production casing, which is a large-diameter pipe that is assembled and inserted into a recently drilled section of a borehole. It is typically held in place by cement. "One thing people don't understand is that if a rig drills a dry hole, we don't work," Thill noted. "But 3D seismic technology has increased the percentage of producing wells. Instead of one out of three, it is now closer to two out of three that we can run casing on."

"We chose to stay out of the horizontal-drilling market," he added. "It is a different market and the equipment is different. The horizontal jobs can take 20 to 36 hours; our jobs take six to twelve. We chose to stick with what we know and are good at."

Thill is a 1981 graduate of Great Bend High School; he earned a degree in business and minor in finance at Fort Hays State University in 1986. He has been in management and sales positions throughout his career. So, Great Bend is home, but it is also "a good, central location for us to operate our business from," Thill commented. "Great Bend is the oil-service hub of Kansas." —

The map is easy to use and offers visitors a fun and powerful tool to help plan their trip in advance. The map will also be a beneficial resource for visitors once they are in the region as well. The iMap controls provide the ability to navigate the map with ease, connecting visitors with the many assets of the byway and its corridor communities of Claflin, Ellinwood, Great Bend, Hoisington, Hudson, Stafford, and St. John. The map provides categories of:

- Where to Stay (hotels, B&Bs, camping, RV parks)
- Where to Eat (local faves, bar & grills, diners, coffee shops, etc)
- What to Do (attractions, tours, recreation, theatre, museums, etc)
- Where to Shop (antiques, unique retail, grocery, gifts, ect)
- Individual Community Lists (all of the above, specific to any community)

The listings consist of comprehensive information including addresses, phone numbers, websites, emails, and even hours of operation. In addition, the iMap provides expanded functionality that traditional maps cannot offer such as GPS coordinates, websites, virtual tours, images, videos, and details that allow trip planners to create and share customizable itineraries or download ready-made itineraries.

"We are very excited to have this expanded online service available for all visitors to our region" said Loren Unruh, Chairman of the Great Bend Convention & Visitors Bureau. Unruh went on to note, "As a hotel owner, I am also glad to have this resource available for staff. They can use the iMap to assist visitors and answer specific questions for the entire byway region."

Walk-a-Mile In Her Shoes Fundraiser Returns May 1st in Jack Kilby Square

The 5th Annual Walk a Mile in Her Shoes, benefiting the Family Crisis Center, will take place Thursday, May 1st from 6-8 p.m. in Jack Kilby Square in Great Bend.



Activities will include a pledge walk, kids' events, and the infamous red heels team race. The event is designed to raise awareness about sexual and domestic violence, as well as raise money to provide services for survivors through the Family Crisis Center and its numerous anonymous services.

There are several reasons why the Crisis Center staff recommends people get involved. First, people have to walk the walk. "There is an old saying that you can't understand a person's experience until you've walked a mile in their shoes," says Crisis Center Executive Director Laura Patzner. "The event is a fun way to let men literally 'walk in her shoes' while raising awareness to fight domestic violence."

Second, Patzner says people need to talk the talk. Opening up communication about sexual and domestic violence helps those who experience it feel like they are not alone in their situation and can reach out to those who can help. The Walk a Mile event is a great way to get people talking.

Third, sexual and domestic violence is not just a women's issue, as it affects the men who care about them. These atrocities are an epidemic, with someone being raped in America every two minutes.

"As we work to bring awareness to the community, please join us to show support for the brave men who will be walking in those red high heels," Patzner says. "Or better yet, ask your family and friends to sponsor you and join us as we Walk a Mile in Her Shoes."

Registration is \$25 for youth participants and \$50 for adult participants. The Ruby Red Prize will be awarded for Top Fundraiser in Youth, Adult and Team categories. Sponsorships are available at 4 levels and can include thirty second commercials during the television special along with other promotional incentives.
