#### Cherry Village opens rehab therapy services department

Residents at Cherry Village Benevolence now have easy access to a three-pronged therapy program at the long-term-care facility. The new on-site service is available to full-time residents, as well as those who need Cherry Village services for only a short time.

"People who are recovering from hip or knee replacements can rely on us during their recovery," explained Melissa Tudor, therapy services coordinator. "Our skillednursing team and therapists are here for anyone who needs us for the long term or even just a few weeks. "We offer therapies that result in consistent progress for a better quality of life," Tudor added. "Families of those who are here for just a few weeks of recovery can count on professionals to help their loved ones return home as soon as possible."

Six new Cherry Village employees are offering physical, occupational and speech therapies. Tudor is a certified occupational therapy assistant. Others on the fully licensed team include an occupational therapist; physical therapist; physical therapy assistant; speech/language pathologist; and a restorative aide who enables residents to maintain mobility and strength after therapy sessions are complete.

Physical therapy involves helping with motor skills such as walking, while occupational therapy entails "getting people back to their daily-living routines," Tudor said. "This includes getting dressed and performing personal hygiene tasks."

Speech therapy can help with a number of issues, she noted. "Often, speech therapy is used when someone has trouble speaking or swallowing and/or is recovering from a stroke," Tudor said. "But it can also be quite helpful when memory and cognition issues are involved."

Donna Marbut, Cherry Village director of nursing, said the therapists are invaluable to the medical staff. "If we notice someone's condition is declining, we can seek input from the therapists right away," Marbut said. "They can help evaluate the situation to determine if a certain therapy would be appropriate."


The therapists perform initial screenings for all residents, "which helps us be even more aware of current or potential problems," Marbut noted. "In addition, when someone is preparing to go home, therapists conduct in-home evaluations. They make suggestions about safety issues and how to avoid problems. "We do all we can to prevent a re-occurrence or a re-admission," the director of nursing added. "We want people to enjoy the comfort of their own homes for as long as possible."

In the past, Cherry Village contracted with a private company to offer therapy services. Now, residents can become well acquainted with on-staff therapists who provide a continuity of care. "It is nice that the residents will see these familiar faces all the time," Marbut said. "That is so important here."

#### **Great Bend Regional Hospital** Recognized for Patient Safety Program Creat Bend



The Kansas Healthcare Collaborative recently recognized Great Bend Regional Hospital for its successful participation in the second round of the national Hospital Engagement Network, known as HEN 2.0, according to Adina Gregory, Chief Operating Officer for the local healthcare leader.

HEN 2.0 was a 12-month comprehensive patient safety initiative conducted by the Centers for Medicare & Medicaid Services through its 'Partnership for Patients' program. The Kansas Hospital Association, along with other healthcare organizations, facilitated the effort within the state of Kansas.

Through the Kansas HEN, Great Bend Regional Hospital worked collaboratively with quality improvement teams at 106 hospitals across the state and 3,700 hospitals across the nation. All were focused on 10 or more core patient safety areas, such as the prevention of falls, infections and adverse drug events. Great Bend Regional Hospital was one of only four hospitals who reported on 100% of the safety measures.

As "Agents of Change," hospital leaders and front line staff participated in learning networks and used quality improvement methods and resources to improve care delivery and prevent harm. The initiative involved engagement at all levels of the hospital, as well as patients and families.

"Patient safety has always been the highest priority for the staff at Great Bend Regional Hospital," Gregory says. "It is insightful to see how our facility compares with other industry leaders from around the state and then implement any processes they have already proven to be successful. I am extremely proud of our staff's commitment to patient safety and their willingness to make additional improvements after participating in this statewide program."

#### More than just Home Improvement...

A few years ago, Matt Hoisington was the guest speaker at an Ellinwood civic club meeting and Dennis Carson was in the audience. It was a chance meeting that would change both their lives. Hoisington represented his employer, the Kansas Department of Commerce, at the meeting where he outlined the operations of nine workforce centers in western Kansas. His job was to match job seekers with employers. Carson owned C & V Home Improvement at the time and wanted to make a change.

"Dennis beat me back to my office," Hoisington recalled. "He wanted to retire but needed somebody to work with him for a year then buy him out. We couldn't find a candidate."

Then the voice in Hoisington's head became louder and louder.

"I come from a family of entrepreneurs," Hoisington said. "My Dad said 'Hoisingtons don't have jobs; we have our own businesses.' I grew up hearing that." As he was listening to the voice, Hoisington became better acquainted with Carson and hired C & V Home Improvement to do window and siding work.

"When the work was done, I was writing a big fat check to him," Hoisington laughed. "I asked if he was still ready to retire. Within a few weeks I decided to buy it." The transaction was official on Feb. 1, 2010. Hoisington kept the C & V name and the business is now located at 1107 10<sup>th</sup>.

"It had that name for 34 years. Most of our business is repeat or referral and name recognition is crucial. Dennis and I say it is a God thing. The good Lord brought us together," Hoisington said, noting C & V has a Christian culture.

Hoisington acknowledged that after the first week he "felt overwhelmed. I talked to Dennis and he said he was bored. He came back on a part-time sales basis and is still here. He will officially retire at the end of the year."

When Hoisington bought the company, it had 10 employees and now has 17, including three at the 3-year-old Hays office. "You can't grow a company like that in one year," he said. "It has to be purposeful and manageable growth."

Originally, C & V was strictly an insulation business. Carson bought out his partner, Larry Vogt, and added siding, replacement windows and doors, seamless steel guttering and garage doors. Hoisington added stucco, cultured stone and egress windows; he sells custom and packaged sheds, and offers awnings and patio covers. C & V collaborates with ProVia, an Amish/Mennonite company in Ohio. "We are co-branding on windows, doors, storm windows and doors, vinyl siding and cultured stone," Hoisington explained. "They are helping us re-design our showroom too. "And I love it that they are not ashamed to tell everyone they are a Christian-based company."

ProVia also offers a computer program that allows customers to visualize options. A photo is overlaid with new siding, for example, and ProVia Studio illustrates what the house will look like. Hoisington also is excited about ProVia internal blinds that are inside the windowpanes where they cannot be damaged.

One unique aspect of C & V is that

installers are employees, not subcontractors. "I pay them well and they have insurance and retirement. They also have workman's compensation, which is so important." For instance, a guttering installer fell at a residence and was flown to a Wichita hospital. Fortunately, everything turned out okay, but if workman's comp hadn't been involved, the homeowner would have been responsible for the flight to Wichita. "I am protecting the customers, as well as my company," Hoisington said. "With subcontractors, you take a risk. We don't chase storms looking for work. We want our guys home and eating dinner with their families."

As a business and family man, Hoisington said the C & V culture demonstrates he values everyone's role in the venture. This includes the customer. "We educate people about their options," Hoisington said. "If you trick



somebody into buying something they don't want, they are not coming back. Subcontractors from out of town have no overhead so they can maybe quote a lower price. But will they be here tomorrow?" Because of this philosophy, C & V reports a 97 percent satisfaction rate. "Our survey asks about everything: how were the buying and installing experiences? Are you happy with how everything turned out? "Unlike big-city contractors, we live here," Hoisington added. "Our kids go to school with your kids. We attend church with you and support local charities. We will never arm-twist you into a sale. It is your money, your home, your decision. Period."

#### St. Rose/HaysMed radiologist recommends annual mammograms



Dr. Michael Wright, radiologist, has been noticing that some women are not having annual mammograms and wanted to take advantage of Breast Cancer Awareness Month to encourage them to reconsider.

Dr. Wright, whose main office is at Hays Medical Center, visits the imaging department at St. Rose Health Center on a regular basis. He speculates that some women over age 40 are not having the exam every year because they are constantly bombarded with contradictory information. While he understands the conflicting reports may be confusing, he encouraged women to consider advice from the American College of Radiology and the Society of Breast Imaging. Their advice is to get an annual mammogram beginning at age 40.

"The guidelines of both these respected organizations are clear," he said. "Unfortunately, people who spread false information through the media can influence patients' decisions. "A mammogram is simply the best tool we have for early detection," he added. "If we can find breast cancer early, there are many successful treatment options that are less invasive than surgery. In some cases, surgery may not be required if it is caught early enough."

Women in central Kansas have the benefit of state-of-the-art digital mammography and diagnostic breast ultrasound at St. Rose, Dr. Wright noted. "The screenings and diagnostic evaluations at St. Rose are extremely helpful to central Kansas residents," he said. "When patients do require more advanced evaluation and/or intervention, HaysMed has the Breast Care Center. It provides breast MRI, advanced ultrasound and 3-D mammography. "In addition, the breast center offers genetic testing and consultation with surgical and therapeutic specialists," he continued. "HaysMed also provides a nurse navigator who guides patients every step of the way."

Mammography also is a valuable tool for detecting benign breast diseases, the radiologist noted. These include cysts, fibrocystic disease, fibroadenomas and lymph-node conditions. "There is another factor to consider when deciding to get a yearly mammogram," Dr. Wright pointed out. "Patients who receive a good report following the exam will have peace of mind, and that is a wonderful thing."
