# St. Rose Adds Vitamin D Test To Menu at Blood Screenings

If you compare the costs of a fractured bone to the cost of the Vitamin D test – well, there is no comparison, said J Doerfler, M.D. Dr. Doerfler, St. Rose Family Medicine physician, said some fractures could affect every part of life, while the Vitamin D test is only \$25. The test is being offered for the first time at the regular St. Rose Health Center blood screening.

The next St. Rose screening is set for 6:30 to 9 a.m. Saturday, February. 27 at the facility. The walk-in event is open to the public on St. Rose's first floor. "Vitamin D is crucial to bone health," Dr. Doerfler said. "It must be combined with calcium to help prevent osteoporosis and bone fractures. A broken bone can cost you thousands of dollars, your mobility and maybe even your livelihood for an indefinite period.

"Some places charge \$250 or \$300 for this test but for \$25 at St. Rose you can determine if you need to be concerned about a deficiency," she continued. "This is equally important for women and men." Vitamin D allows calcium absorption and is added to some foods. However, sunshine is the best source of the vitamin.

Bone pain can be one symptom of a deficiency, Dr. Doerfler said, noting menopausal women and newborns without breast milk may be more apt to lack Vitamin D. The family-medicine doctor noted that Vitamin D is fat-soluble, which means it can be stored in the liver. "Other vitamins pass through urination," she said. "But Vitamin D works differently." Dr. Doerfler suggests talking with a primary-care physician about a recommended dose for a Vitamin D supplement that should be coupled with calcium. "They work together as a team," she said. "Your doctor can help you figure out the right amount for each."

Other tests offered at each St. Rose blood screening are a \$25 blood profile that involves a complete blood count; comprehensive analysis of more than 20 blood chemistries; lipid profile for breakdowns of cholesterol and triglyceride numbers; and a thyroid test. Fasting is highly recommended. However, it is not necessary to fast before the other two blood tests. One is the \$16 PSA that checks a man's prostate and the other is the \$7.50 HGBA1C test for diabetes.

Neither a doctor's referral nor an appointment is required; cash and checks are accepted. St. Rose specializes in primary care, prevention and wellness.



### **Golden Belt Community Foundation Begins Law Enforcement Campaign Thanks To Anonymous Donor**

A friend of the Golden Belt Community Foundation recently approached Christy Tustin with an idea. The local man, who has chosen to remain anonymous, asked the Foundation executive director if they could collaborate on an awareness campaign about the lives and jobs of local law enforcement officers. The result will be a series of monthly articles that focus on local police and sheriff's officers, as well as other public servants. "This Foundation donor is concerned about the negative attitudes toward police that we are seeing around the country," Tustin said. "He wants to remind people that police officers are out there every day protecting and serving us. "Oftentimes," Tustin commented, "it is difficult for law enforcement officers to tell heir own story. We want to be the voice of these hidden heroes."



The Foundation donor and Tustin chose January 9, which is National Law Enforcement Appreciation Day, to officially begin this project. "After learning about the special day, we realized it was tailor-made for this local campaign," Tustin said. "One goal is to demonstrate to law enforcement officers that we recognize the difficult career they have chosen and they have our gratitude. After all, they run toward trouble while the rest of us run away from it." The Foundation's mission can be addressed in many ways but to put it simply, it connects donors to causes they care about, Tustin noted. "This project will be no exception," she commented. "The Foundation doesn't have just a single way of meeting its goal of furthering charitable interests throughout our service area. We are always open to new avenues leading to stronger, healthier communities."

Throughout the 2016 campaign year, the donor hopes to: improve the public's perception of law enforcement officers and other public servants; find more ways to educate young people; and learn why officers chose this career. "We hope to start a dialogue with our series of stories," Tustin said. "Children and adults should realize that police and sheriff's officers are people they can turn to when they are in trouble. ### **AMC To Offer In-House Stem-Cell Therapy**



From day one, Dr. Nels Lindberg has been proud of his clinic's technology and commitment to state-of-the-art veterinary practices. However, Animal Medical Center's most recent addition to its ever-growing list of services is probably one of the most scientific therapies offered in the area.

"Stem cell therapy, otherwise known as regenerative medicine, isn't a new idea. "In layman's terms, we extract the animal's own stem cells from their fat tissue and put them back in the body where they are most needed."

Regenerative medicine can be used to treat a myriad of animal conditions, such as joint pain and arthritis, tendon and ligament trauma, soft tissue wounds, skin allergies, and more. "The goal of regenerative medicine is to bring injured tissue back to its original pristine condition," Lindberg says. "Stem cells and progenitor cells are extraordinary because they can grow and divide many times, and can form many types of tissue through a process of specialization called differentiation."

In some cases, enough cells can be harvested and grown so that a surplus can be saved for future use. Once injected, the stem cells give rise to the specific type of tissue that has been damaged, allowing for accelerated and natural healing to occur. "Some animals can see the benefits within a few days, while others may take a few weeks," Lindberg says. "But one treatment can make all the difference between a pet being able to climb stairs or jump into a vehicle, and being in constant pain."

Animal Medical Center partners with MediVet Biologics to offer this revolutionary new therapy in-house at their clinic, located at 622 McKinley in Great Bend.

Animal Medical Center offers full-service small and large animal care including vaccinations, spay and neuter surgeries, acupuncture, animal chiropractic, ultrasound diagnostics, cold laser therapy, surgical laser, digital x-ray, endoscopy, regenerative medicine (stem cell therapy), all aspects of bovine and equine medicine, surgery, consultation, and much more. Retail products for pet care and nutrition are also available, and they boast a clean open-hospital environment.

### **Developmental Milestones, Early Intervention**

While about a dozen local and area non-profit entities are involved in a new project, they each want the same thing – for young children to be screened early for developmental issues. The project will entail handing out packets of information to public-health facilities and agencies that care for young children. The packets will then be distributed to parents who will learn about the early signs of potential problems. This effort is being organized in conjunction with the Centers for Disease Control (CDC) campaign called "Learn the Signs. Act Early. "We want to reach out across central Kansas to educate parents," said Cathy Estes, Children's Services Coordinator at Sunflower Diversified Services. "Not all parents are aware of some developmental milestones until their children lag further behind their peers."

This is why Sunflower has teamed up with its local Interagency Coordinating Council (ICC) partners. Sunflower owns and operates its Early Education Center and Incredible Years Preschool, both at 1312 Patton in Great Bend. Its ICC partners include Parents as Teachers, special-education preschools, health departments, the Center for Counseling & Consultation, Barton Community College and Connecting The Pieces Autism Support Group. "The welfare of children is our utmost concern and it takes this level of teamwork to reach the families who need us," Estes said. "We can be so much more effective collectively; one agency cannot do it all. "Each ICC member has specific talents and requirements but the bottom line is to provide an avenue to early intervention. "We all work with each other every day," Estes commented. "For example, a child in Sunflower's early intervention program may be referred to Parents as Teachers play group. The extra socialization with peers is crucial."

The ICC's information packets will include a refrigerator magnet with a resource directory. David Edgerton of La Crosse designed it. "David and his wife, Katrina, have been a big help to us," Estes said, noting they have a child in early intervention services. "David has an eye for the graphic arts and the technical know-how to bring them to life. "Other items in the packets include written materials about developmental milestones and a pre-literacy children's book. Packets will be distributed in February, March and April. "These easy-tounderstand materials are invaluable," Estes said. "For example, pre-literacy starts the process for reading and writing, and identifying sounds and speech. Infants learn to look at the pictures as you talk about them. "By 4 months, they should be babbling and following your finger as you point," she continued. "They start smiling and laughing at the sounds you are making. And by 6 months, babies start making vowel sounds. This interaction leads to identification of words." McKinley Phillips, Sunflower early childhood special education teacher, knows the importance of milestones not just in her professional life; she is now mother to 6-month-old Wylder.

"Wylder is doing just great but I still understand that screening children as early and often as possible is very important," Phillips said. "Once a child develops a delay, there can be a snowball effect that places the child further behind. Intervention services can prevent this. "Sunflower's free developmental screenings by our professional team are extremely helpful to any parent," she added. "We can suggest activities, strategies and resources for the child's successful development."

The packet materials cost about \$2,600. Kanye Cross Autism Awareness donated \$750 and Sunflower has kicked in \$1,400. BCC's Early Childhood Department purchased \$500 worth of pre-literacy books. Sunflower's Early Ed Center is part of the tiny-k infant/toddler program in Kansas. The non-profit agency's service area includes Barton, Pawnee, Rice, Rush and Stafford counties. Although it is funded in part by tax revenue, it relies on private donations; services are free to families.

### Sunflower Bank Kicks-Off ABC Program To Promote Education For 15th Year

### **BCC Rolls Out "Occupational Safety and Health" Certificate Program**

Whether it is a small, independent construction business or a massive corporation with hundreds of employees, all industrial based businesses must dedicate time and manpower to safety on the jobsite. It is with that in mind that Barton Community College at Grandview Plaza has rolled out a specialized "Occupational Safety and Health" certificate program. Barton is one of only 42 government sanctioned Occupational Safety and Health Association (OSHA) education centers in the U.S. and it is the only one in Kansas. This program can only be taught by an official OSHA education instructor and in a certified facility.

The program will be broken into two certificates either certificate has either certificate can be taken with either a construction or industrial emphasis. The first level is 6.5 credit hour "Specialist in Safety and Health" certificate. The second level is the 14 credit-hour "Certified Safety and Health Official" certificate. Barton's Dean of Fort Riley Technical Education and Military Outreach Training Bill Nash said, "Students gaining these certificates will be ahead of the curve when employers are looking for employees in industrial settings."

"Industry professionals are looking for people with safety backgrounds," Nash said. "Any manufacturer or construction business for example, will have to have a safety-trained person. These qualifications are what make a good foreman or supervisor and there are dedicated safety positions available. This training gives people the base knowledge they need to go look at the workplace and do a job hazard



analysis, see what employees are actually doing and they can then apply intent of the regulations to that and they're able to make the workplace safer. They can then develop programs and training based on their analysis."

Nash said the program is not only aimed at traditional full-time students, but also at people who are already working in the industry and building their skillset and what they have to offer to their employers.

"It's possible that adding these skills and qualifications could lead to a substantial pay raise and solidify even more so, a position that they already have if they can complete this program," he said. The program is guided by an advisory board that includes substantial business and industry executives as well as government safety officials.
